I. Purpose of This Document

This Mission and Philosophy Overview present the foundational identity, mission structure, and governing philosophy of The SAVI Ministries for the benefit of visitors, supporters, potential partners, and institutional evaluators reviewing the ministry for the first time.

It is designed to be read alongside the institutional website at thesaviministries.org and serves as the primary standalone reference document for those who wish to understand the ministry's purpose, organizational structure, and institutional character before engaging with deeper materials.

II. Foundational Identity

The SAVI Ministries is a faith-centered nonprofit church and humanitarian institution organized as a Washington State nonprofit religious corporation. The ministry operates under the statutory church exemption provisions of Section 508(c)(1)(A) of the Internal Revenue Code and was formally incorporated on March 18, 2022, with UBI No. 604 891 114.

The ministry is founded upon the conviction that authentic spiritual life must express itself through service to others. Faith is not merely a matter of belief but a lived commitment to compassion, healing, and the upliftment of human life. The work of the ministry therefore seeks to unite spiritual formation with practical humanitarian action, disciplined governance, and long-horizon institutional stewardship.

The SAVI Ministries is structured to pursue this mission through an institutional framework capable of enduring across generations. Rather than relying on episodic fundraising or short-term initiatives, the ministry is building a permanent platform designed to sustain its mission through disciplined governance, responsible capital stewardship, and long-horizon planning.

III. The Integrated Mission Model

The mission of The SAVI Ministries is expressed through a model that integrates four mutually reinforcing dimensions of institutional purpose. These dimensions are not treated as independent activities but as complementary expressions of one coherent calling.

Dimension One: Spiritual Teaching and Formation

The ministry supports the proclamation of the Gospel of Jesus Christ and the dissemination of spiritual teachings that encourage individuals to deepen their awareness of the divine presence within life. Through



written publications, educational materials, and spiritual reflections, the ministry seeks to strengthen the spiritual foundations of individuals while contributing to a broader culture of compassion and responsibility.

Dimension Two: Humanitarian Compassion and Service

The ministry seeks to express its spiritual commitments through practical acts of compassion that support individuals and communities facing hardship. Humanitarian initiatives may include charitable outreach, support for vulnerable populations, and partnerships with organizations engaged in the relief of human suffering. These efforts are guided by the belief that service to others is an essential expression of spiritual life.

Dimension Three: Human Restoration and Integrative Wellbeing

A further dimension of the ministry's work concerns the restoration of individuals seeking healing and renewal. The ministry recognizes that personal transformation often requires attention to the full spectrum of human wellbeing, including spiritual awareness, physical health, emotional healing, and supportive community.

Dimension Four: Responsible Institutional Stewardship

The fourth dimension involves the long-horizon stewardship of the institution itself. The SAVI Ministries has been designed with governance structures and financial policies intended to preserve the ministry's mission and resources across generations. Through the establishment of an endowment foundation and disciplined capital management, philanthropic contributions are stewarded in a manner that supports the mission not only in the present but far into the future.

IV. The Three Execution Engines

For institutional purposes, the mission of The SAVI Ministries is organized through three coordinated execution engines that together form one integrated humanitarian platform.

Engine One: Faith Aligned Humanitarian Network

The Faith Aligned Humanitarian Network is a distributed partnership infrastructure composed of affiliated churches, ministries, nonprofits, and allied humanitarian entities. This network provides organized field access to communities and regions that larger institutional systems often fail to reach effectively. Partners within this network carry out mission activities aligned with the spiritual and humanitarian values of The SAVI Ministries, operating with independence while sharing a common commitment to compassionate service.

The network is not a loose affiliation or directory. It is a structured field access system : the organized ground-level presence of the institution's humanitarian mission.

Engine Two: Angel Mercy Flights

Angel Mercy Flights is the humanitarian aviation capability of The SAVI Ministries. It is designed to extend mission reach to populations, communities, and environments that ground-based logistics and larger aviation systems cannot efficiently serve. Using general aviation aircraft capable of operating from smaller airstrips in remote and underserved environments, this capability provides last-mile humanitarian access : the ability to reach those who are most isolated from institutional assistance.

Angel Mercy Flights is positioned as a precision humanitarian aviation access system and represents one of the most distinctive institutional capabilities of The SAVI Ministries.



Engine Three: The SAVI Ministries Endowment Foundation

The SAVI Ministries Endowment Foundation is the long-horizon capital stewardship engine of the institution. It exists to preserve, govern, and grow mission-supporting capital in perpetuity. The Endowment Foundation is governed by a formal Investment Policy Statement, an Endowment Governance Charter, and a Spending Policy designed to protect the real purchasing power of endowed capital while making disciplined distributions in support of the ministry's mission activities.

The Endowment Foundation represents the institutional commitment to permanence: ensuring that the ministry's capacity to serve does not depend on the generosity of any single generation but is preserved and strengthened across generations through disciplined stewardship.

V. Governing Philosophy

Faith as Foundation

The SAVI Ministries is a Christian religious organization grounded in the proclamation of the Gospel of Jesus Christ. Its institutional identity, governance posture, and mission orientation are anchored in the belief that every human being bears the image of God and possesses inherent dignity, worth, and spiritual significance. This conviction is the basis of the ministry's humanitarian work, not a supplement to it.

Institutional Seriousness

The ministry is committed to operating with the same level of institutional discipline, governance rigor, and fiduciary seriousness expected of the most respected philanthropic foundations and endowments. Governance structures, stewardship policies, and institutional architecture have been designed not merely to meet baseline requirements but to reflect the ministry's belief that stewardship of resources entrusted by others is a moral obligation inseparable from the mission it serves.

Long-Horizon Orientation

The SAVI Ministries has been architected for permanence. Every governance decision, capital structure, and institutional design choice reflects an orientation toward multigenerational continuity rather than near-term efficiency. The ministry recognizes that lasting humanitarian and spiritual impact requires institutions that are built to endure, not organizations that burn brightly in one era and leave no structure behind.

Relationship to The SAVI Group

The SAVI Ministries serves as the humanitarian implementation of the fourth pillar, a human-centered approach to business, within The SAVI Capital Model developed by The SAVI Group. This relationship informs the philosophical and institutional framework of the ministry without displacing its primary identity as a faith-centered nonprofit church and humanitarian institution. The SAVI Ministries retains its own distinct legal identity, governance structure, and spiritual mission.

VI. Institutional Status and Registration

The SAVI Ministries is organized and operates as follows:

- Washington State nonprofit religious corporation under RCW 24.03A
- UBI No. 604 891 114 — incorporated March 18, 2022



- Recognized as a church and religious organization under Section 508(c)(1)(A) of the Internal Revenue Code
- Also registered as a foreign nonprofit in the State of Florida
